The initial authorization will be inforce for a period of 1 (one) year (effective from the date of issue of this authorization) subject to the compliance of all terms and conditions as enclosed herewith.

- M/s. Sanjib Bhagawati & Associates, 116, Panipath, N.E. Geetanagar, Guwahati, Assam-20 is hereby granted an authorization to operate a facility for storage & transportation of E-Waste & Scrap Batteries inside & outside of Assam.
- The authorization is granted to operate a facility for storage & transportation of Hazardous Wastes.
- The initial authorization shall be in force for a period of 1 (one) year from the date of issue of this authorization.
- The initial authorization is subject to the conditions stated below and to such conditions as may be specified in the rules for the time being in force under the Environment (Protection) Act, 1986.

## TERMS AND CONDITIONS OF AUTHOURISATION

- The authorization shall comply with the provisions of the Environment (Protection) Act. 1986 and rules made there under from time to time.
- The authorization or its renewal shall be produced for inspection at the recoest grant officer authorized by the Pollution Control Board, Assam.
- M/s. Sanjib Bhagawati & Associates, 116, Panipath, N.E. Geetanagar, Guwahati, Assam-20 shall
  not rent, sell, transfer or otherwise transport the hazardous waste and without obtaining prior
  permission of Pollution Control Board, Assam.
- Any unauthorized change in personal, equipment on working conditions as mentioned in the application by the person authorized shall constitute a breach of this authorization.
- It is the duty of M/s. Sanjib Bhagawati & Associates to take prior permission of the Pollution Control Board, Assam to close down the facility.
- The provisional authorization is meant only for storage & transportation of Hazardous Waste generated by the unit in an environmentally sound manner. Disposal must be done only to the authorized and registered recycler/ re-processors.
- 7. M/s. Sanjib Bhagawati & Associates may store the Hazardous Wastes for a period of not exceeding 90 days and shall maintain record of the hazardous waste and make this record available for inspection by the Board official as and when asked for.
- M/s. Sanjib Bhagawati & Associates should have "Pollution Under Control Certificate" (PUCC) during the transportation of Hazardous Waste and shall be properly displayed.
- The Vehicles used for transportation should be dedicated for transportation of Hazardous Waste only and shall not be used for any other purpose.
- 10. Transportation of the Hazardous Waste shall be in accordance with the provisions of Hazardous Waste (Management, Handling & Trans boundary Movement) Rules 2008 and the rules made by the Central Government under the Motor Vehicles Act 1988 and other guidelines issued from time to time in this regard.
- 11. M/s. Sanjib Bhagawati & Associates shall provide the transporter with the relevant information in Form-11, regarding the hazardous nature of the wastes and measure to be taken in case of an emergency and shall make the Hazardous Wastes containers as per Form-12.
- 12 For transportation of Hazardous Wastes through a State other than the State of origin or destination, necessary intimation must be done to the concerned State Pollution Control Board before hands over the Hazardous Wastes to the transporter.
- 13. M/s. Sanjib Bhagawati & Associates must prepare six copies of the Manifest in Form-13, under the provision of Rule-21 of the Hazardous Waste (Management, Handling & Trans boundary Movement) Rules 2008.
- 14. M/s. Sanjib Bhagawati & Associates shall be fully responsible for any type of spillage of Hazardous Wastes during handling of Hazardous Waste.
- 15. M/s. Sanjib Bhagawati & Associates shall be legally bound under this authorization to co-operate and comply with the direction issued by the Board.
- 16. M/s. Sanjib Bhagawati & Associates is to follow all other regulations as per Hazardous Waste (Management, Handling & Trans boundary Movement) Rules 2008.
- 17. M/s. Sanjib Bhagawati & Associates will submit quarterly compliance report and return regarding handling & disposal of Hazardous Wastes in Form-4 and must submit before 30<sup>th</sup> June every year.
- 18. M/s. Sanjib Bhagawati & Associates must follow the Batteries (Management & Handling) Rules 2001 for collection, reception, transport, storage and disposal of scrap batteries.
- 19. This authorization can be revoked at any time if the implementation of the stipulated conditions is not to the satisfaction of the Pollution Control Board, Assam.
- 20. Any other conditions for compliance as per the guidelines issued by the Ministry of Environment & Forests, Govt. of India, New Delhi or Central Pollution Control Board, Delhi from time to time.
- 21. Non compliance of any one or more conditions as stipulated above shall also be liable to prosecution under the Environment (Protection) Act, 1986.
- This authorization is conditional subject to the renewal of consent under the Water (Prevention & Control of Pollution) Act, 1974 & Air (Prevention & Control of Pollution) Act, 1981. Wherever, such consent/ authorization lapsed the unit will not commence operation till valid, consents under Water & Air Act.
